What's New in 2025?



- TRS-Care Medicare Advantage will have lower premiums for the 2025 plan year. In future years, we'll need to determine limited increases based on market trends and rising health care costs.
- Limited-Time Enrollment Opportunity allows Medicareeligible TRS retirees and their eligible dependents to enroll in or rejoin TRS-Care Medicare Advantage.
- **Dental and Vision Benefits** are coming to TRS-Care on January 1, 2025. Enrollment starts October 1, 2024.

TRS' thorough plan management

Maintaining the long-term stability of the TRS-Care fund is top priority

- Limited-Time Enrollment Opportunity allows Medicare-eligible retirees (and their eligible dependents) to enroll or rejoin the plan.
- In the coming years, we will actively manage the plan and implement limited premium adjustments based on market trends and rising healthcare costs.

TRS-Care Medicare Advantage Premiums for PY2025



Participants will save between \$720 - \$4,884 annually.



Inpatient hospitalization	\$500 per stay after deductible
Outpatient surgery	\$250 copay after deductible
Medical virtual visits*	\$0 visit using AmWell, Doctor on Demand and Teladoc

Diabetes Testing and Monitoring Supplies



When you use one of the approved meters and corresponding strips, your cost share for diabetes testing and monitoring supplies is \$0.

These supplies include any brand of:

- Lancets
- Lancing device
- Glucose control solution (to test the accuracy of your meter)
- Replacement batteries for your meter



Plus, your plan provides coverage for many of the OneTouch and ACCU-CHEK blood glucose testing strips and meters*



Medicare Part D Drug Payment Stages



Participant: You pay copays (or less) through all stages in 2025

1. Deductible Stage (\$590 for 2025): **No pharmacy deductible**, you pay

your copay

2. Initial Coverage Limit Stage (N/A): You pay your copay

3. Catastrophic Stage (over \$2,000): You pay \$0



Medicare Part D Drug Payment Stages



SCENARIO: Ronald takes Jakafi 10mg (specialty brand) at a 31-day supply.

The cost of this medication is \$3,667.65.

Here's what would happen with a "marketplace" plan vs. TRS-Care Medicare Rx®:

Diabetic Supply Coverage



Meters, Lancets and Test Strips: Use your TRS-Care Medicare Advantage (UnitedHealthcare) card at the pharmacy to get these supplies at no added cost to you.



Needles and Syringes: Use your TRS-Care Medicare Rx (Express Scripts) card to fill these through a participating pharmacy (like CVS, HEB, Walgreens, Walmart or Target) or via Express Scripts home delivery. These are at no added cost to you.



Communications from TRS-Care Medicare Rx®



Joining us soon? You'll get:

- Turning 65 Packet from TRS TRS will mail this packet 90 days before your 65th birthday month. It will contain your summary of benefits.
- Welcome Kit from Express Scripts ESI must mail this packet within 10 days after CMS approval.

You can only have one Part D plan at a time. If you have Part D coverage when you join TRS-Care Medicare Rx[®], you will be disenrolled from the other plan.
